President's Perspective

Moving On

Hurray for us! After three years of COVID-19 delays, we were finally able to have our 37th Annual Meeting this year in Bowling Green. Coincidentally, 2023 marks the 40th anniversary of Kentucky Public Retirees. It was created in 1983 as the Kentucky Society of Public Annuitants. While our attendance was not as we had hoped, Carol Douglas and her Barren River Chapter put together a great event, and I want to thank each one of them again for their efforts. In 2024, we will be moving back to Lexington to the Clarion Hotel and Conference Center – mark June 13/14, 2024, on your calendars.

Now then, what's next? Clearly, it's the 2024 General Assembly where we hope to convince that body to fund a pension supplement for all public retirees. As I write this on July 1, I note that it has been 12 years since we last received a COLA. The Bureau of Labor Statistics tells us that for each dollar we received on that long-past date, it would take \$1.38 to make up for it today. We all know that – and every legislator knows that as well. It's one reason why active employees are receiving a 6 percent raise today on top of the 8 percent raise they received this time last year (including the legislators). Our job over the next months is to convince our elected representatives that providing some sort of pension supplement – be it a 13^{th} check, a COLA, whatever – is the right thing to do for Kentucky's public retirees.

By the end of July, the state budget director will present his report on Fiscal Year 2023, and it is predicted to show that Kentucky ended the year, again, with about a \$1 billion surplus. This is on top of the \$2 billion from the last two years. It is from this perhaps \$3 billion pool that we want to carve out about \$200 million for retirees. (The actual amount will depend on what form the pension supplement takes.) I don't think this is too much of an ask, even though everyone else will be clamoring for a piece of it as well. It's our time; it's our turn.

As the Session draws nearer in January, each of us will need to become advocates. While legislators spend time in Frankfort between Sessions at committee meetings, they are back in their home districts probably just as much, if not more. This is where that personal contact when you see them out and about in your hometown becomes so important. We can tell them that the average KPPA pension is about \$18,500 per year or that 67 percent of KPPA pension recipients receive less than \$20,000 per year. But if each of us were to tell them our own personal stories about what a little boost would mean in our day-to-day lives, I believe it would be more impactful. Give them something to remember. Also keep in mind that 2024 is an election year in which all 100 representatives and 19 senators (in the odd numbered districts) will be asking us for our vote. It would not be too impertinent to remind them that your vote for them could well depend on their vote for us.

> At our rally in January 2016 when our benefits as a whole were being threatened, we adopted the phrase "WE EARNED IT!" as we protested the proposed changes. It's not too much to say that again, today.

Membership Update

Legislative Chair Update

With the 2023 Legislative Session behind us, we look to the Interim Committee meetings held between June and the first of December to see what issues may become "hot" during the 2024 Session. In particular, these include State Government; Appropriations & Revenue, especially its Budget Review Subcommittee on General Government, Finance, Personnel & Public Retirement; and the Public Pension Oversight Board. Nothing of significance from these yet. We monitor the agendas of these committees for their oversight roles of the public pensions and either attend personally or view remotely as appropriate.

During the Interim, meetings of the Public Pension Oversight Board are either the 4th Monday or Tuesday of each month (1 p.m. ET), are open to the public in the Capitol Annex Room 154, or available for remote viewing through either KET or the LRC's own live feeds at: <u>https://legislature.ky.gov/Public%20Services/PIO/Pages/Live-Streams.aspx</u>.

As of this writing, there have been no bills pre-filed and posted to the LRC home page on any topic.

Kentucky Public Pensions Authority Update

Committee and board meetings for KPPA/KRS/CERS continue for 2023 and are available online as they occur or after the fact. You can view these meetings in an area set up at KPPA for this specific purpose, or on Facebook live, or anytime by choosing the meeting from the "About", then "Meeting Calendar" tabs on the KPPA website.

In the last couple of months, the most consuming item has been the creation of the new, non-merit, independent auditor for KPPA, a position now designated as the chief auditor and mandated by HB 587 (23RS). In addition to the position itself, the existing Joint Audit Committee has had to be written out of the bylaws for CERS, KRS, and KPPA and new language added for the new KPPA Audit Committee.

It has been decided to hire the existing executive director for

Internal Audits, Kristen Coffey, into the new position but details, such as salaries for herself and staff have yet to be determined.

Investment returns going into the final quarter of FY23 show a positive April, slightly negative May, and (likely) a positive June. The end of the year should find the pension and insurance plans as having met their assumed rates of return – not spectacular like FY21 but as-planned to stay on track for full funding.

One item to note is that the current KPPA CEO, David Eager, has announced his intention to retire as of June 30, 2024. This will set off a chain of activity as the organization searches for a new leader. Eager has been CEO since 2017 and will have a long list of accomplishments to his credit as he steps aside.

And as always, my summary of all KPPA, CERS, KRS, Public Pension Oversight Board, and any other pertinent meetings are posted on the KPR Facebook page shortly after they occur.



Barren River - In May we met at the Barren River Area Development District (BRADD) Office. Chapter President Carol Douglas stated that the primary purpose of the meeting was to finalize plans for the upcoming KPR Annual Meeting. Nine members attended the meeting.

President Douglas addressed the need to fill all chapter officer positions. The positions of vice-president and secretary remain open. The other officers and committee chairpersons have agreed to continue serving in their current positions. President Douglas said that the chapter received acknowledgement of our donation to Guide Dogs for the Blind which was made in memory of Shirley Clark. The chapter also received a thoughtful thank you card from Shirley's family. The chapter voted at the April 2023 meeting to purchase two pre-paid VISA cards for door prizes for the Annual Meeting. Several Barren River KPR members have donated additional door prizes for the meeting. There was discussion regarding speakers for future meetings. Suggestions included getting a speaker regarding scams, a geriatric doctor regarding aging gracefully, Angela Welch regarding My Sister's Keeper (shelter for women), and someone from GRADD to speak about seniors and senior services.
