## President's Perspective by Larry Totten


In reading some article about pension systems a short time ago, I came across an interesting definition of the word fiduciary: "An individual in whom another has

placed the utmost trust and confidence to manage and protect property or money. The relationship wherein one person has an obligation to act for another's benefit." We all know how this applies to the KRS Board of Trustees/Directors – KRS 61.650 (1) (c) even codifies the requirement that they discharge their duties "Solely in the interest of the members and beneficiaries." What was intriguing to me about this definition was the second sentence.

I have come to believe that all of us are also fiduciaries. We obviously are not responsible for the pension and insurance trust funds themselves, but I do think each of us has an obligation to act for another's benefit, in this case that of our fellow retirees. Our defined benefit plan is at its core one based on our fiduciary responsibility to each other. Defined benefit plans such as ours protect the retirement income of our entire KRS membership, both those retired and those still working, not leaving individuals on their own to plan for a life of uncertain length, uncertain income, or uncertain ability to navigate through a labyrinth of investment vehicles. The contributions we paid into the Systems while working went toward the benefits being paid to retirees at that time and provided funds that were invested for future benefit payments.

Now that we are retired, this responsibility has shifted from the monetary to the participatory. KPR exists to advocate for the pension security for all public retirees. We do this by speaking up in defense of the pensions we all earned – as well as in defense of benefits yet to be received by others - because we all are truly in this together. Talk to your legislators when you see them in your community and continue to have them at your monthly chapter meetings. Make them commit to the security of pension benefits for all of us. It is only by joining together with one voice that we can even hope to overcome those forces that might deny us our benefits.

As we go into the upcoming legislative session, there are a couple of things we need to keep an eye on. There are, of course, a few bills that have already been pre-filed.



There are transparency bills in various flavors as well as a "peekaboo" proposal that would give anyone the right to find out what your pension benefits are. As the Session draws nearer, we can expect to see more filings, especially if there is some decision out of the court system regarding the Governor's reorganization of the KRS Board in 2017. By the end of the year, we should see the report from The PFM Group regarding pension plan "best practices" now ongoing. This one could also spawn some legislation.

Finally, one thing that should come up is the issue of state revenue in the form of tax reform. It isn't really a secret that the increased ARC funding that was provided in the current budget was funded by cuts to state agency budgets and a huge \$375 million sweep from the Public Employees Health Insurance Trust Fund. Just to keep the same employer contribution in the budget that will come out of the 2018 General Assembly will require this same level of funding. Where does it come from then? Is there another fund with that kind of balance that can be swept? Not likely. Whether one agrees with it or not, government funding comes mostly from taxation. There has been study after study on "reform" and each of these has been shelved. We know that the KERS NH and SPRS funds can't be salvaged by investment income, so additional revenue has to be provided. There is talk about dealing with this in a special session, but groundwork has to be done before convening one of these; so we'll have to watch to see what path this may take.

As you will be reading this in mid-December, I want to wish each of you a happy holiday season. 2017 will be upon us and there will be work to be done. And remember, our pensions are not handouts –

#### **Legislative Chair Update**

There have been three meetings of the Public Pension Oversight Board (PPOB) since our last Kernel. In August, the topic was a presentation of investment returns by each of the three pension systems. In September, staff of the LRC presented an investment review comparing and contrasting the three pension systems' programs with each other with a particular emphasis on hedge funds. In October, stakeholder groups were invited to address the Board as they begin to coalesce their recommendations for consideration by the 2017 General Assembly; KPR was one of eight groups presenting. Following these, the three pension systems presented their own priorities for consideration. Recommended legislation will be finalized at the PPOB meeting in December.

As of mid-November, there are eight pre-filed bills pertaining to KRS. Several deal with the topic of transparency in one form or another to include more disclosure of information on the pension plans' websites and the procurement and disclosure of contracts under the Model Procurement Code. There are two which would move legislators and judges from their existing plan into KRS. There are also two that would require, on request, the disclosure of "projected or actual retirement benefit payments" of participants in all three state pension plans.

There are likely to be more bills presented for consideration as we move toward January and the start of the General Assembly based on either the final report presented by The PFM Group and their study of the state's pension plans at the end of December or the outcome of the Elliott v Bevin lawsuit slowly winding its way through the court system.



#### **Retirement System Update**

There has been only one KRS Board meeting since the last publication of the Kernel. On August 24, a called Board Meeting convened with the primary purpose of naming an Interim Executive Director. Board member and Investment Committee Chair David Eager was named for this position. The group also received an update on the then-ongoing process of bringing KRS staff back under the 18A umbrella. The last Board meeting of the year will be December 1 and will be a busy one. Both the FY16 audit and actuarial valuations will be presented and the Comprehensive Annual Financial Report (CAFR) that is provided to the state should be available for approval. Financial performance through at least September should also be made public. Several committee recommendations requiring final approval by the Board should also make the agenda.

Since summer, the Investment Committee has been busy with two regular meetings and two called ones. The first meeting in August was relatively routine with discussion on proposed investments. The first of the called meetings in October made headlines with the decision that KRS would divest itself of its hedge fund portfolio. There was also discussion regarding cash flow and the KRS' securities lending program. The first meeting in November continued the securities lending discussion but also brought the first cut of which hedge fund investments would be divested. The second November meeting resulted in a change to the intermediary bank handling the securities lending program and also had a good discussion on a re-alignment of asset allocations and actuarial assumptions. Look for this committee to meet at least one time before the next regular meeting as they set KRS investing on a new path.

The Retiree Health Plan Committee met in September to approve the rates and a few other details regarding the rates KRS would be covering for both the under-65 and Medicare-eligible retirees. The Audit Committee had its regularly scheduled meeting in November which included discussions on the release of the FY16 audit, FY16 actuarial report, FY16 CAFR, and the upcoming CERS elections. The financials discussed will not be publicly available until after the December Board meeting. The Committee was also made aware of an ethics complaint made by Personnel Secretary and Board member Thomas Stephens against KERS elected director Vince Lang.

The next few months will likely bring about more changes to KRS as the courts and the legislature make decisions on how the agency operates. Stay tuned.

#### SAVE THE DATE!

The Kentucky Public Retirees' 2017 annual meeting will be held on June 15-16 next year at the Capital Plaza Hotel in Frankfort. Room rates will be \$89, which will include a hot buffet breakfast. 

KPR President Totten attended the meeting and gave an update on changes in the legislative makeup.

We were enlightened by the comments from these two gentlemen who believe, with commitment and effort, our pension problems and other issues facing our legislators and governor can be resolved to make our state more productive and help us meet our budget goals. **Jefferson Regional** - Kasey Maier, of the Waterfront Botanical Gardens, presented a slide show at the September meeting about the proposed gardens and educational pavilion which will be the heart of the Waterfront in Louisville. She informed us they needed volunteers in different capacities, and how the public can play a role in the Garden's future.

Pettyjohn, Kentucky Retirement Systems Director of Retiree Health Care, who spoke on our KRS health insurance benefits for 2017 for both Medicare-eligible retirees and non-Medicare retirees.

On November 9, our program was a forum of the six announced candidates for the two open CERS seats on the KRS Board of Directors. The candidates each made remarks, followed by a Q & A session.

On December 14, our speaker will be David L. Eager, Interim Executive Director of KRS. He oversees all day-to-day operations of KRS and reports to the KRS Board of Directors. He also serves as the KRS liaison to the Executive Branch agencies, the General Assembly, and the general public. We will also have our annual Christmas Toys for Tots Drive.

**Northern Kentucky -** Our September meeting was our annual picnic held at Mainstream Farm with Milton and Cathy Kunkel-Mains as our hosts. We enjoyed wonderful weather playing bingo and corn hole, and we had a wonderful homemade meal.

The October speaker was Tom Fromme, who is the City Manager for Newport. Tom gave a very informative and humorous presentation on the development underway in Newport, Kentucky.

The November speakers were Tom Geimeier and Jerry Auton, co-authors of "The Second Fifty: Your Roadmap to Fitness and Healthy Aging." Larry Totten, KPR's President, also visited and addressed our concerns on the spousal membership bylaw. He agreed to place it on the agenda for the December Board meeting. He said the Governor and legislature will to have to come up with a similar amount in the 2018 budget just to keep pension funding where it is now and that they likely could not raid the Insurance Fund again.

We do not meet in November since our meeting date falls on Thanksgiving Day, but we will meet the first Thursday in December at Country Cupboard which will be a fun meeting. The meeting was to have been planned by our Vice President, Donna Slaton; however, Donna has been very ill and needed to be hospitalized while on vacation in the Smoky Mountains. 
**Sign up for the KPR Bulletins** - We'll be regularly shooting you informative emails about issues which directly affect your retirement benefits.

KPR has changed our system for sending email alerts to our members. All members must subscribe to the new system to receive emails with important information from the KPR State Board. To receive *The Kernel* by email or to receive dues notices by email you must subscribe to the new system.
